ADDITIONAL REQUIREMENTS AND SELECTION CRITERIA

BIOLOGY AND BIOTECHNOLOGY

It is recommended to submit the application only after verifying that the selected Universities have suitable conditions for carrying out activities compatible with your study curriculum. This includes the equivalence of offered courses to those in the study plan of Pavia, the potential for practical labs and thesis activities, as well as the required level of language proficiency. Please note that candidates selected for thesis work abroad must identify a supervisor from their degree program or university willing to oversee their thesis presentation, and a laboratory willing to host them at the chosen Erasmus destination. Upon their return, they must submit a certificate or letter from the foreign supervisor/institution confirming the conducted lab/research activities.

CHEMISTRY

For students attending a laboratory course abroad, it is mandatory to submit a certificate (or a letter issued by the supervisor) upon return, confirming their attendance in the laboratory.

COMMUNICATION

After submitting the application, candidates must send their CV and provide academic and personal motivations by completing the form at the following link:

MATHEMATICS

MEDICINE AND SURGERY

Eligible candidates include:

University of Pavia – Attachment III to the Erasmus Call for Study 2024/25

- Students enrolled for the academic year 2023/24:
 - in the I, II, III, IV, V year of the Single Cycle Master's Degree in Medicine and Surgery (LM41 Golgi and Harvey Course)
 - in the I and II year of the Bachelor's Degree in Nursing, Dietetics, Sports Science, Physiotherapy, Neuro and Psychomotor Therapy, Occupational Therapy, Biomedical Laboratory Techniques
 - in the I, II, III, IV, V year of the Single Cycle Master's Degree in Dentistry and Dental Prosthetics
 - in the I year of the Master's Degree in Sports Sciences and Techniques and Preventive and Adaptive Motor Activities
- Students enrolled in Specialization Schools and Research Doctorate courses affiliated with the Faculty, meeting the fundamental requirements for participation.
- Students enrolled in the Medicine and Surgery program must have passed the preliminary exams as per the course's curriculum for the year of application.
- For students enrolled in the VI year in 2023/24, as well as repeaters or out-of-course students, the Commission will evaluate individual requests and related issues accordingly.

CLARIFICATIONS

- The Erasmus Medicine Area Committee is composed of the International Mobility Delegate of the Erasmus Area as President, along with faculty members from the Golgi and Harvey Medicine and Surgery program, and a representative from each of the other affiliated degree programs.
- When designing the study program to be carried out abroad, it is essential to adhere to the prerequisite exams stipulated by the Italian educational system and verify the core curriculum of the chosen subjects, ensuring alignment with the Italian standards. Specifically:
 1. Normally, it will not be possible to advance exams from subsequent years, except after careful evaluation of each case, focusing on the regularity, rationality, and completeness of the proposed program, while considering credit covalence and educational value.
 2. It is preferable to include integrated courses in the learning agreement rather than individual course modules. However, due to the diverse educational offerings at partner institutions, study plans will be evaluated on a case-by-case basis. If it becomes necessary to include only modules from an integrated course, the remaining parts of the course can be completed upon return to UNIPV.
 3. Study plans aiming to remediate deficiencies from previous years in an inappropriate or incongruous manner, not integrated into an overall curriculum plan, will not be accepted.
- Given the above guidelines, specifically for students in the Medicine degree program, it is discouraged to apply for Erasmus before the third year and during the sixth year (as finding compatible study plans at partner institutions that do not involve advancing or remediating courses is very challenging). The sixth year should primarily be reserved for thesis work.

MUSICOLOGY AND CULTURAL HERITAGE

MOBILITY INCENTIVES: Upon completion of their degree, students who have participated in an Erasmus+ program or training activities during study periods at foreign universities will receive an additional score of 1 point for the Bachelor's and Master's degrees in Literary Studies and Cultural Heritage, as well as for the Bachelor's and Master's degrees in Musicology.

PSYCHOLOGY

Students interested are encouraged to visit the UNIPV Psychology - Erasmus section website for specific and updated information.

DRUG SCIENCES

Prospective applicants must contact the exchange coordinator before submitting their application to ensure proper guidance. For conducting the thesis abroad, it is required to have obtained 150 ECTS credits by the application deadline.

EARTH AND ENVIRONMENTAL SCIENCES

No specific requirements are expected.

BUSINESS AND ECONOMICS

CHANGE OF DESTINATION AND ALLOCATION OF AVAILABLE PLACES

The student cannot request a change of the assigned destination based on their ranking position and preferences indicated in the application.

If a student applies for Universities where places have already been assigned to students ranked higher, they may compete for any remaining vacant places that are compatible with their language test results and their study level and field. The date of the reassignment meeting will be communicated simultaneously with the publication of the results of the current Erasmus selection.

THESIS RESEARCH

Students interested in conducting research for their thesis during the Erasmus mobility period must verify, before submitting their application, the availability of the foreign institution to accept Erasmus students for this purpose. To do so, students should directly contact the Erasmus coordinator at the foreign University.

POLITICAL AND SOCIAL SCIENCES
